  - A YOUNG PERSON'S PARISH SHOULD BE THE FIRST RESOURCE OF FINANCIAL SUPPORT. PARISHES ARE DIRECT BENEFICIARIES OF THE KCYC EXPERIENCE. THERE MAY BE GROUPS WITHIN THE PARISH THAT ARE WILLING TO SUPPORT THIS OPPORTUNITY FOR YOUTH.
  - SOME FORM OF FUNDRAISING SHOULD BE USED. ASSISTANCE AND/OR IDEAS CAN BE OBTAINED FROM YOUR PARISH YOUTH MINISTER OR THE DIOCESAN YOUTH OFFICE.
